Procedures and practices regarding dormant accounts and unclaimed property in safe deposit boxes have come under attack by both consumers and state agencies that are entitled to escheatment. This webinar explains the Uniform Unclaimed Property Act and the tools that every institution needs to evaluate its practices regarding dormant accounts and unclaimed property. There is a quick review of the basic rules before focusing on more advanced issues. Since escheat laws vary, this webinar does not cover state-specific escheat laws. However, you are able to find your state-specific escheat laws by using the contact information provided.
