The Illinois Community Reinvestment Act (205 ILCS 735) was signed into law on March 23, 2021. The Community Bankers Association of Illinois (CBAI) and other stakeholders worked with Illinois Department of Financial & Professional Regulation (IDFP) and the Joint Committee on Administrative Rules for three years to negotiate rules to implement the new law. Those rules were approved and went into effect on July 1, 2024. Under the rules, state-chartered banks can expect to see State CRA exams as early as late 2025. This session provides information for state-chartered banks on the new standards and requirements to comply with this new act.

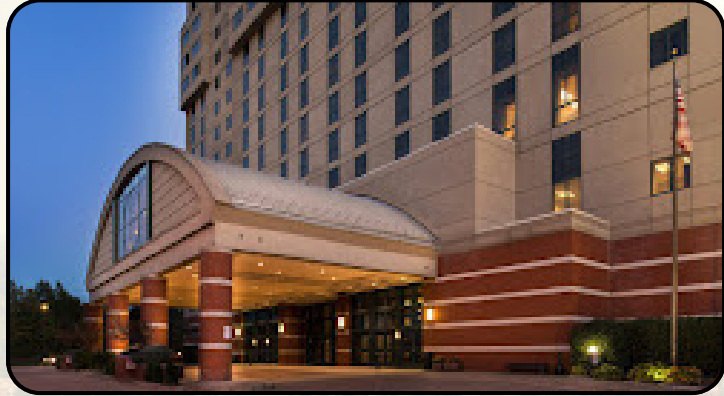

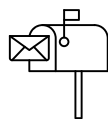
