### “Current Trends in International Cybercrime: The Underground Check Fraud Ecosystem”

Playing defense against sophisticated cybercriminals and fraudsters is usually too little and too late. To win, financial institutions must deploy proactive threat intelligence that detects imminent threats with greater speed, accuracy, and effectiveness. Learn how to leverage the Deep and Dark Web forums and known malware infrastructure to collect highly targeted and actionable and threat intelligence.

**Robert Villanueva** is executive vice president and currently leads the Cyber Threat Intelligence Division of Q6 Cyber, based in Miami, FL, and Tel Aviv, Israel. Villanueva joined Q6 Cyber after 25 years of dedicated service in the United States Secret Service, where he specialized in transnational cybercrimes, access device fraud, network intrusions, and identity theft data breaches affecting the private sector. Villanueva founded the U.S. Secret Service’s Cyber Intelligence Section, which coordinates global cyber operations and headed the U.S. Secret Service’s Miami Electronic Crimes Task Force, which counts 800+ members from the private sector, academia and local/federal law enforcement.

**Eli Dominitz** serves as chief executive officer of Q6 Cyber. Q6 offers a unique intelligence enabled solution that transforms the way organizations defend against cyber threats. The Q6 Cyber team consists of cybersecurity experts with extensive backgrounds in Israeli and U.S. intelligence organizations. Prior to Q6 Cyber, Dominitz co-founded another cybersecurity company focused on third-party (vendor) risk management.
